Rules

These addendum rules of supervision will be applied to any offender under the supervision of Allen County Community Corrections for any sex offense, unless otherwise ordered by the court, or unless otherwise required by statute.

I acknowledge, understand and agree that:

- 1. _____ Pursuant to IC 11-8-8-7, I shall register as a sex offender with the local law enforcement within seven (7) days of release to ACCC. If I am defined as a sexually violent predator (as defined in IC 35-38-1-7.5), I will register with the local law enforcement within seventy-two (72) hours of being released to ACCC.
- 2. _____ Pursuant to IC 35-38-2-2.2 and IC 35-38-2-2.5(c), I will not reside within one thousand (1,000) feet of school property and I will not reside within one (1) mile of the residence of the victim of my sex offense.
- 3. _____ I will not possess obscene matters as defined by IC 35-49-2-1 or child pornography as defined in 18 U.S.C 2256(8), including but not limited to: videos, magazines, books, DVDs, and material downloads from the internet. I will not visit strip clubs, adult bookstores, motels specifically operated for sexual encounters, bars where partially nude or exotic dancers perform, or business that sell sexual devices or aids.
- 4. _____ I will attend, actively participate in, and successfully complete a certified sexual perpetrator treatment program that utilizes polygraph testing in order to ensure compliance with the ACCC Sex Offender Addendum. Responsibility for payment of fees required for treatment, including polygraph testing, will be mine. Unsuccessful termination from treatment or noncompliance with treatment conditions will be considered a violation of my placement. I will not be allowed to change treatment providers unless the Court grants me prior written permission.

If you are classified as an “Offender Against Children” as defined in IC 35-42-4-11, you must also abide by the following conditions. For offenses not covered under IC 35-42-4-11, the Court may order any of the following conditions if deemed appropriate, given the elements of your offense.

- 5. _____ Pursuant to IC 35-42-4-11, if I am classified as an ‘Offender against Children’ I will not reside within a thousand (1,000) feet of school property, a youth program center, a day care center licensed under IC 12-17.2 or a public park and I will not establish a residence within one (1) mile of the victim of my sex offense.
- 6. _____ Pursuant to IC 35-38-2-2.4 and IC 35-38-2-2.7, I will have no contact with any person under the age of _____ years of age unless I receive Court approval. Contact includes face to face, telephonic, written, electronic, or any indirect contact via third party.

- 7. _____ Pursuant to IC 35-38-2-2.7, I will not use social networking, websites, instant messaging, or chat room program to communicate directly, or through, an intermediary with a child less than _____ years of age. This includes my own child, step-child, sibling, or another relative. If I want to communicate with my child, stepchild, sibling or another relative by using social networking website, an instant messaging, or chat room program, I may only do so with a written order of the Court that specifically names the relative(s) with whom I can communicate.
- 8. _____ Pursuant to IC 35-38-2-2.2, I am prohibited from accessing or using certain websites, chat rooms, or instant messaging programs frequented by children. I am prohibited from deleting, erasing, or tampering with information on my personal computer with intent to conceal an activity prohibited by this condition. I will consent to the search of my personal computer or device with internet capability at any time and to the installation on my personal computer or device with internet capability, at my expense, of one (1) or more hardware or software systems to monitor internet usage. I must register all internet capable electronic devices with my case manager and probation officer.
- 9. _____ I will inform all persons living with me of current and prior convictions. I will notify my case manager of any changes in my home situation or marital status within twenty-four (24) hours.
- 10. _____ I will not possess any pictures of a child or children not related to me. I will not possess any pictures of my victim.
- 11. _____ Pursuant to IC 35-42-4-12.5, I will not possess and / or operate a drone to follow, contact, or capture images or recordings of one (1) or more person(s).
